

Xcel Energy Bill Assistance

Instructions for EOC Application:

1) Verify your eligibility

- a. You must have Xcel Energy,
- b. Your gross annual household income (i.e. all work and non-work income before taxes or deductions) at or below 80% of area median income (AMI). Refer to the table provided in the application,
- c. You must be at least one day past due, on your bill,
- d. And you can only receive the funding once a year. The year is October to October

If to the best of your knowledge you have not received EOC funds in last year and you meet the above requirements, please continue to the next step.

2) Complete the following application:

- a. Pages 1 and 2 are the EOC funds application which allows for the request of funds for bill assistance.
- b. Pages 3 and 4 are a Consent to Disclose for Xcel Energy, this allow us to look at you bill balance in order to pay the proper amount as well as speak with Xcel on your behalf if needed.
- c. Pages 5 and 6 allow you to verify your income eligibility based on your county of residence.

Once you have completed the application, please move on to the next step.

3) Attach a copy of your latest bill and your photo ID.

Once you have the completed application, as well as a copy of your photo ID and latest bill, you can return it via email to: assistanceprograms@cotable.org, or you can return it to the Community Table lobby to be given to Assistance Programs.
